**Discussion:** Legislator Carl Belfiglio qualified the Chairman of the Legislature appoints

committee members. This resolution creates and re-establishes the UC Trails Advisory Committee for the purposes of advising the legislature on trail-related issues, adoption, repeal or amendments to laws and regulations as they relate to UC trails, and the appointments for (3) Legislators, James Delaune, Johnathan Heppner and Craig Lopez, among other notable appointments not to exceed

(13) voting members.

**Text of Motion:** Resolution No. 128 – Urging The Governor And Legislature Of The State Of

New York To Gradually Restore The 50/50 State/County Cost Sharing For The Safety Net Program And To Increase Shelter Grant Reimbursements To

Counties

**Discussion:** Legislator Belfiglio who is the sponsor of this memorializing resolution noted

the resolution frame work originated at the NYSAC convention during the Health and Human Services Committee. Legislator Belfiglio made the motion to amend the eighth WHEREAS on the resolution to include "Ulster County"

has budgeted \$11.2 million in the 2016 budget."

Amended to state: WHEREAS, for the first half of 2015, State data indicates that county Safety Net costs have increased by nearly 9% over the prior year; and Ulster County has budgeted an additional \$11.2 million in the 2016

budget; and

All committee members asked to have their name added to the amended

resolution.

Ken Crannell explained the current safety net program and the 100% reimbursed federal TANIF program that services women and children having a

5-year life time limit - benefits program for families.

Under state law when families age out of the federal welfare program they automatically become eligible for safety net benefits. He noted Ulster County served 170 families- almost 500 individuals last year.

Legislator Heppner expressed his support for the state paying their fair share of the safety net program, noting the increase in his constituent tax base utilizing the program. Legislator Heppner felt the fifth whereas offers up a different debate vs. policy and fiscal realities noting the wording, (only 11 states provide benefits to childless adults that do not have some disability.)

MOTION NO. 4 Resolve to Approve Resolution No. 131 for March 15, 2016 Session

**Text of Motion:** Resolution No. 131 – Setting A Public Hearing On Proposed Local Law No. 3

Of 2016 (A Local Law Protecting Children From Exposure To Toxic

Chemicals) To Be Held On Tuesday, April 12, 2016 At 6:00 PM

**Discussion:** This proposed local law "The Children's Product Safety Act" is designed to protect the health and safety of its residents, particularly children, who are the

most vulnerable. Many common children's products contain toxic carcinogenic chemicals, whereas exposure can cause harmful effects to the red

blood cells, causing cancer in humans.

Legislator Belfiglio wanted to learn more about the issue being presented from all sides, parents and industry – to have equal representation prior to setting a public hearing and public hearing participation. Also who pays for the toys selected for testing once opened? Also Legislator Belfiglio would like the retailer to have reasonable notification – 2 weeks prior to the inspection.

Legislator Roberts asked Ken Crannell if there are any grants available for the purchase/leasing of testing equipment – costing upward of \$50K/ ea. Ken noted he is not aware of any. He also expressed concern with the penalty phase – with the possibility of the health department writing the violations and the health commissioner being judge and jury. Legislator Roberts qualified Section 4 wording – federal law vs. guidelines / regulations for lead and mercury parts per million for children's toys, (clothing and jewelry excluded). "Federal law" is established for mercury and lead. "Guidelines" are established for all other toxic chemicals. The American Society for Testing and Materials, (ASTM) offer standards that cover other heavy metals found in toys such as cadmium. ASTM is a non-government organization.

Legislator Allen questioned what input the health department provided and if there is a list of retailers within the county. Also how would the required enforcement, resources, and documentation upkeep weigh on the health department? Legislator Allen recommends a list of defective/banned products be compiled and built upon included in the local law - informing store management. Clean & Healthy New York Deputy Director Bobbi Chase expressed a chemical list will be made available in the spring beneficial to vendors. Legislator Allen noted our proposed local law doesn't have to be exactly the same as Suffix County.

Legislator Heppner feels the inspections will be less intrusive with the 10/10 program - (10) retailers per quarter and (10) products inspected, and also allowing the retailer the ability to remove the defective products from the shelf. The health departments experience with similar inspections such as restaurant inspections should help for a smooth transition with retailers.

Committee discussion ensued regarding enforcement, education, testing equipment, timeframe and inspection cycles.

In summary Chairman Lopez would like to take more time and get this important legislation right to be effective for all parties.

Legislator Bartels, co-sponsor of this resolution thanked the committee for their attention and input and asked that no action be taken at this time to allow time to confer with co-sponsor Legislator Mary Wawro, county health department, Deputy Executive Ken Crannell, and Clean and Healthy New York, to work on the creation of rules customized to Ulster County - make changes before presenting additional information at next month's meeting. Legislator Bartels will forward information as it becomes available to the committee clerk who will forward onto the committee.
