Legislator Richard Parete and Ken Crannell concurred the current program was primarily established for county vehicle usage, whereas this new grant is primarily dedicated for public usage. Legislator Greene commended both Amanda LaValle for her hard work, always being ahead of the curve and the Energy and Environment Committee for really going through a deliberative process by bringing people in.

Legislator Greene shared the desire for a fire training center in Ulster County, who personally looked at the site and received numerous calls from surrounding neighbors about the effects of ground water contamination, actual site design, noise, storm water, smoke, wetland habitat and wildlife effects, among other factors. Legislator Greene would like to bring the community together for an open dialogue of the project and also consider other sites. Legislator Loughran questioned the RRA property as a potential site; however the fire service has rejected this site possibly due to inadequate acreage. Committee discussion ensued.
