Old Business:

Chair Petit mentioned having a more robust discussion on forthcoming Resolution No. 541 in the next committee meeting. Deputy Executive Kelly shared that there remains approximately \$400,000.00 from the original appropriation for American Rescue Plan Act (ARPA) Water and Sewer projects, and recommended that it be opened up to people who did not receive funding. He also stated that he would discuss this with the Chair and Deputy Chair of the ARPA Committee.

Chair Petit shared with the Committee that a letter was sent to the New York State Department of Transportation Regional Director, Lance MacMillan, citing concerns about the ungated rail crossings along Kings Highway in Saugerties. Director Doyle shared that Transportation Council will make a decision regarding following up a county-wide safety study.

Legislator Erner has asked what local outreach has transpired to address residents' abilities to travel within the county. Director Doyle stated that pedestrian and bicycle accommodations are being considered, and that the private sector has been encouraged to improve pedestrian and cyclist infrastructure for which they are liable for.

Barbara Budik thanked Chair Petit and the Committee for sending the letter to state representatives.

Hearing no new business, at approximately 7:30 PM, the Transportation Discussion ensued. Topics included the creation of a matrix of information and actions that previous discussions have produced, including public transportation notifications, bus driver grade increases and training discussions,

county-funded fares, and bus shelter improvements, including schedules in bus shelters, as well as other topics, such as areas in the county that are underserved, upcoming routing software, inviting legislators to use the bus system, requesting updates on a micro-transit grant application, transportation accessibility for disabled and older persons, business partnerships to support bus route optimization and bus shelter improvements, accessibility of UCAT public meetings, available positions within UCAT, inventory, accessibility and safety of bus shelter locations, inter-county efforts and the possibility of building support for a state transit system, the unaffordability of private bus systems for many residents, discussions to have with the Ulster County Transportation Council, marketing of available county employment, supporting other departments that transport residents, and water transport
