Legislator Maloney summarized that the cost of this will mostly affect individuals visiting Ulster County and not the residents of Ulster County. The residents of Ulster County will however benefit from increased revenue. Legislator Maloney also stated that the delay in finalizing this resolution has also cost the county millions of dollars that could have been used for housing.

Legislative Chair Bartels informed the committee that she is not in favor of two different rates for hotels / motels and short-term rentals and would like to find one rate for all entities and would like to send one bill up to the state that also incorporates the definition changes. Legislative Chair Bartels also expressed support for dedicating a portion of the revenue to the creation of workforce housing and giving a portion of the short-term rental revenue to the towns.

Legislator Cahill stated support for a single tax rate.

Legislator Walter shared agreement for one single tax rate and was in favor of asking the state for the increase and work out the policy details while awaiting state approval for the increase.

Chair Gavaris questioned the legality of having two different tax rates. Chair Gavaris also added that for municipalities to receive money they should be cooperating and change zoning when able as there are several areas within Ulster County where the zoning prohibits affordable workforce housing.

Legislative Chair Bartels requested a one-month postponement to discuss the definition changes.

Discussion ensued on the tax percentage that various legislators were comfortable with and the potential impacts on tourism growth.

Legislator Petit noted that the owner of a company is not easy to find, and it should be available.

Legislative Chair Bartels added that there isn't a downside to the transparency aspect when having this type of information available when public funds are being used.

Deputy County Executive Kelly questioned what this change would look like.

Chairman Gavaris envisioned this as part of the bid document and noted that he is familiar with bid documents that include the answers to questions such as: 'do you have an interest or does a family member have an interest in the company' or do 'you have a relationship with anyone who has a position of influence'.

Chair Gavaris also expressed issue with voting for a salary increase for the current term and not a future term.

Legislator Walter noted that she didn't like that the salary increases were listed together as she doesn't want the other elected officials to be affected.

Legislator Uchitelle clarified that this is the process that is outlined in the charter and that the process itself should change if there are issues with the process.

Legislative Cahill noted that removing the legislature from the Resolution would be a substantive change and require a new public hearing.

Comptroller Gallagher informed the committee that \$163 Million was collected of \$143 Million Budgeted for sales tax, for 2022, and there is still one final payment yet to be received. Occupancy Tax is at \$3.6 Million or 126% of its budgeted value but Comptroller Gallagher does not believe that the full short-term rental market is being captured and is being reviewed by the Comptroller's Office. In addition, \$1.2 Million of interest income has been earned since the increased rate at Bank of Green County, however, an additional \$280,000 could have been earned by investing with NYCLASS.

Comptroller Gallagher noted that the Comptrollers Office is finalizing their delinquent real property tax audit and the annual risk assessment process is well underway and encouraged all legislators to reach out at any point.

Comptroller Gallagher informed the committee that the new state budget radically changes the in-rem process and puts a huge burden on the Commissioner of Finance by taking the equity realized from the sale of a foreclosed property and gives it back to the taxpayer instead of the county. All liens will need to be reviewed for residential and commercial properties and will cost the county money. Legislative Chair Bartels confirmed that the equity transferred to the previous homeowner is the sale price less back taxes and fees. Commissioner of Finance Gulnick expressed several areas of concerns including a scenario where an owner creates a LLC and puts a lien on their own property. Commissioner of Finance Gulnick also noted that the New York State Association of Counties (NYSAC) has been collecting the input from counties.

Commissioner of Finance Gulnick added that the rates for assigned council are moving from \$75 to \$158 per hour. Legislative Chair Bartels requested a memo that quantifies the changes.

Chairman Gavaris asked if there was any old or new business.
