WHEREAS, the purpose of the NYS DCJS SASP award is to support rape crisis centers that provide core services, direct intervention, and related assistance to victims of sexual assault, regardless of age; now, therefore, be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to execute a contract #T652441, and any amendments thereto, with the New York State Division of Criminal Justice Services for the Sexual Assault Services Program grant in the amount of \$17,358.00 for the term July 1, 2025, through June 30, 2026, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney and Legislative Counsel,
