WHEREAS, the Ulster County Legislature appropriated to the Ulster County Soil and Water Conservation District the sum of \$181,500.00 in the 2025 Ulster County Budget; and

WHEREAS, the Ulster County Soil and Water Conservation District has requested an increase bringing the total appropriation request for 2026 to \$187,000.00; and

WHEREAS, pursuant to County Law Section 223 (1), in order to receive such funds, the Ulster County Soil and Water Conservation District must submit to the Ulster County Legislature a verified accounting of disbursements to be undertaken, and to the Legislative Financial Analyst and the Ulster County Commissioner of Finance, a Memorandum of Receipt signed by the principal officer; now, therefore, be it

RESOLVED, the Chair of the Ulster County Legislature is hereby authorized to execute an agreement in the amount of \$187,000.00, to be expended towards the costs associated with operations of the Ulster County Soil and Water Conservation District, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, Counsel to the County Legislature, Chair of the County Legislature, and the Chair and Deputy Chair of the Economic Development, Planning, Education, Employment, Arts and Agriculture Committee; and, be it further

RESOLVED, that all funds expended pursuant to this agreement shall be dispersed after filing with the Office of the Clerk of the Legislature all documentation relating to the completion of an annual external audit of the Soil and Water Conservation District; and, be it further
