Chairwoman of the Law Enforcement and Public Safety Committee, Gina Hansut, and Deputy Chair Chris Hewitt offer the following:

WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Probation; and

WHEREAS, Ulster County in collaboration with the New York State Division of Criminal Justice Services (DCJS), the New York State Department of Corrections and Community Supervision DOCCS), and Family of Woodstock has established the County Re-entry Task Force (CRTF) to more effectively coordinate the delivery of re-entry services that address the needs of individuals released from state incarceration to achieve successful community reintegration, lower recidivism, reduce victimization, and increase public safety; and

WHEREAS, Ulster County has designated the Family of Woodstock, Inc. as the entity responsible for implementation of the CRTF; and

WHEREAS, Ulster County, NYS DCJS, NYS DOCCS, and Family of Woodstock wish to enter a Memorandum of Understanding that delineate their respective roles and responsibilities with respect to their commitment to support re-entry service delivery in NYS with the County Re-entry Task Force; now, therefore be it

RESOLVED, the Chair of the Ulster County Legislature is hereby authorized to execute a Memorandum of Understanding with the New York State Division of Criminal Justice Services, the New York State Department of Corrections and Community Supervision, and Family of Woodstock for the County Re-entry Task Force that delineate their respective roles and responsibilities with respect to their commitment to support re-entry service delivery in NYS, and any amendments hereto with approval of the County Attorney,

and moves its adoption.
