WHEREAS, the term of the agreement to automatically renew for successive one-year periods unless terminated by either party; now, therefore be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the NYS Department of Corrections and Community Supervision to provide a certified courtroom within the Sheriff's Office to serve as a Parolee Hearing room until terminated by either party in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,

and moves its adoption.
