WHEREAS, this resolution has been submitted at the request of the Ulster County Sheriff; and

WHEREAS, the Saugerties Central School District has requested one (1) Deputy Sheriff be assigned as a School Resource Officer (SRO) at locations as requested by the District; and

WHEREAS, the Saugerties Central School District will pay Ulster County an amount not less than \$46,858.00 for the services of the Deputy Sheriff assigned as the School Resource Officer; and

WHEREAS, the term of the agreement shall be January 1, 2026 through June 30, 2026; now, therefore, be it

RESOLVED, that the Chair of the Ulster County Legislature is hereby authorized to sign an agreement, and any amendments thereto, with the Saugerties Central School District to provide one Deputy Sheriff to serve as a School Resource Officer for the term January 1, 2026 through June 30, 2026, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney; and, be it further,
