WHEREAS, further pursuant to Resolution No. 426, 11 members of the Committee are subject to confirmation by the Legislature, including seven (7) at large members who regularly use the public transportation system; and four (4) from community and/or philanthropic organizations i.e. paratransit, trails, bike safety etc. who advocate for people in need of public transportation; and

WHEREAS, in accordance with Resolution No. 426, candidates interested in serving on the TRIAC completed an application with resume for review by the legislative committee charged with oversight of transportation, then the Public Works, Capital Projects and Transportation Committee; and

WHEREAS, a subcommittee of the Public Works, Capital Projects and Transportation Committee was formed and met for the purpose of reviewing applicants and making recommendations for appointment to the TRIAC; and

WHEREAS, Resolution No. 95, adopted March 18, 2025, appointed one member representing community and/or philanthropic organizations, Ella Ray Kondrat, for a term set to expire on December 31, 2025; and

WHEREAS, Resolution No. 95, adopted March 18, 2025, appointed one At Large member, Michael Kondranksy, for a term set to expire on December 31, 2025; and

WHEREAS, Ella Ray Kondrat has reapplied, expressing interest in continuing to serve on the Committee; now, therefore be it

WHEREAS, Michael Kondranksy has reapplied, expressing interest in continuing to serve on the Committee; now, therefore be it
