WHEREAS, the Ulster County Department of Mental Health has received notification from the New York State Office of Addiction Services and Support (OASAS) for increased funding for \$76,800 to support roof repairs at Rehabilitation Support Services, Inc as per the New York State Office of Mental Health (OASAS) State Aid letter; and

WHEREAS, to reflect the increased funding, an amendment of the 2025 budget is necessary; and

WHEREAS, there is no increase in County Contribution as a result of these modifications; now, therefore be it
