

Approving The Execution Of A Contract For \$699,746.00 Entered Into By The County – Astor Services For Children & Families – Department Of Mental Health

Chairman of the Health, Human Services and Human Rights Committee, Abe Uchitelle, and Deputy Chair Craig V. Lopez offer the following:

WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Astor Services for Children & Families has been submitted for approval by the Ulster County Legislature, which is described below:

2026-52 - New York State Office of Mental Health funding for (a) a Health Home Non-Medicaid Care Management program, which provides services to children/youth with serious emotional disturbance; (b) a Health Home Care Management Service Dollars program; (c) a Family Peer Support Services program; (d) operation of a warm line for families participating in the Families Together program, which will provide peer support as well as skill building to parents whose children are enrolled in Families Together; and (e) Home Based Crisis Intervention services	88% State 17% County	Other	1/1/26 - 12/31/26	\$699,746.00
