WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Public Works; and

WHEREAS, Capital Project No. 651 originally established pursuant to Resolution No. 641 of December 19, 2022, in the amount of \$265,000.00; and

WHEREAS, Resolution No. 641 of December 19, 2022, allowed the transfer of funds between Capital Projects Nos. 649 through 652; and

WHEREAS, the Budget Department approved budgetary transfers allowing for the current budget of capital project No. 651 to be \$406,000.00; and

WHEREAS, the Department of Public Works requests that Capital Project No. 651 be amended to increase funding by \$48,500.00 for additional bridge materials; now, therefore be it

RESOLVED, Ulster County has determined that this funding action does not pose a significant potential environmental impact and may be progressed as a Type II action in accordance with 6 NYCRR Part 617 of SEQRA, and does not require any further determination or procedure under SEQRA; and, be it further

RESOLVED, based upon examination by the Ulster County Legislature, the County's funding of this Project constitutes a Type II action as defined under Section 4.5.5 of the County of Ulster's State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; and, be it further
