He or she shall serve at the pleasure of the County Executive”*; and

WHEREAS, the County Executive has appointed Adam Sessler as the Director of the Department of Risk Management; and

WHEREAS, pursuant to Sections C-15 of the Ulster County Charter and Sections A2-10 of the Administrative Code, the above-referenced appointment is now subject to confirmation by the Ulster County Legislature; now, therefore, be it
