Chair Criswell Announces 2026 Annual Legislative Calendar and Standing Committee Appointments

(Kingston, NY) – Ulster County Legislature Chair Peter Criswell today announced the 2026 Annual Legislative Calendar and confirmed committee assignments and leadership for the upcoming year. The committee structure includes eight standing committees, each tasked with advancing policy, oversight, and fiscal stewardship on behalf of Ulster County residents.

“I’m inspired by this new class of legislators — they are serious, smart, hard-working, and compassionate, all qualities that make a good legislator,” said **Chair Peter Criswell**. “Adding them to the mix of dedicated returning legislators makes me optimistic that we’ll be able to continue addressing critical issues in our county, including housing, food security, transportation, healthcare, environmental stewardship, community safety, and infrastructure needs. These committee assignments reflect both experience and balance, and they position the Legislature to do meaningful, responsible work in 2026.”
