WHEREAS, this resolution has been submitted at the request of the Ulster County Sheriff; and

WHEREAS, the approved 2026 – 2031 Capital Improvement Program includes the amount of \$500,000.00, for a Sheriff’s Garage and Impound Yard; and

WHEREAS, the Ulster County Sheriff requests that Capital Project No. 756 be established and funded so that the department can address the need to create a safe functioning impound yard; now, therefore be it

RESOLVED, based upon examination by the Ulster County Legislature, the County’s funding of this Project constitutes a Type II action as defined under Section 2.2 of the County of Ulster’s State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; and, be it further

RESOLVED, Ulster County has determined that this funding action does not pose a significant potential environmental impact and may be progressed as a Type II action in accordance with 6 NYCRR Part 617 of SEQRA, and does not require any further determination or procedure under SEQRA; and, be it further

RESOLVED, that Capital Project No. 756 – Ulster County Sheriff Impound Yard is hereby established as follows:
