

**Reappointing Members To The Ulster County Industrial Development Agency Board Of Directors**

WHEREAS, pursuant to Article 18-A, Title 1, Section 856 of the New York State General Municipal Law: *“Except as otherwise provided by special act of the legislature, an agency shall consist of not less than three nor more than seven members who shall be appointed by the governing body of each municipality and who shall serve at the pleasure of the appointing authority. Such members may include representatives of local government, school boards, organized labor and business. A member shall continue to hold office until his successor is appointed and has qualified”*; and

WHEREAS, the members of the former Economic Development, Planning, Education, Employment, Arts and Agriculture Committee interviewed candidates, and recommended the below-mentioned individuals for appointment to the Ulster County Industrial Development Agency Board of Directors for a term that expired December 31, 2025; and

WHEREAS, all sitting members have expressed interest in continuing to serve on the Board; and

WHEREAS, given the shortened Legislative term, the Ulster County Legislature deems it appropriate to reappoint all current members of the Ulster County Industrial Development Agency Board of Directors for the purposes of continuity and facilitation of effective management of current and ongoing business before the Board; now, therefore be it
