

**Establishing Capital Project No. 750 Ulster Landing Road Embankment Stabilization Project – Amending The 2026 Capital Fund Budget – Department Of Public Works (Highways & Bridges)**

Chair of the Public Works and Capital Projects Committee, Kathy Nolan, and Deputy Chair Jason Kovacs offer the following:

WHEREAS, this resolution has been submitted at the request of the County Executive on behalf of the Department of Public Works; and

WHEREAS, Ulster County is committed to protecting its infrastructure and responsible for the maintenance of roadside slopes and embankments; and

WHEREAS, DPW has identified a section of approximately 735 linear feet of roadway and embankment along Ulster Landing Road in the Town of Ulster has experienced significant settlement and deterioration, and is in need of stabilization; and

WHEREAS, the approved 2026 - 2031 Capital Improvement Program includes a project “Ulster Landing Road Improvement Project” in the total amount of \$2,400,000.00; and

WHEREAS, the Commissioner of Public Works requests funds for the Project in the amount of \$2,300,000.00; now, therefore be it

RESOLVED, based upon examination by the Ulster County Legislature, the County’s funding of this Project constitutes a Type II action as defined under Sections 4.5.5 of the County of Ulster’s State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; and, be it further

RESOLVED, Ulster County has determined that this funding action does not pose a significant potential environmental impact and may be progressed as a Type II action in accordance with 6 NYCRR Part 617 of SEQRA, and does not require any further determination or procedure under SEQRA; and, be it further
